## PLAYER TERMS AND CONDITIONS

I, being the parent/guardian of the player identified in this agreement, understand and agree to the following:

- 1. I understand that playing football involves risk of injury. I understand that I must ensure my child has adequate health insurance as Murray United FC (MUFC) or Football Victoria FV is under no obligation to meet any additional medical costs incurred by the player. I understand FV insurance is not intended to be a substitute for private health insurance and that I will need to evaluate my insurance requirements.
- 2. In case of emergency, I authorise the person in charge to consent where it is impossible to communicate with me, to my child receiving such medical treatment as may be deemed necessary by a qualified medical practitioner.
- 3. I agree to communicate with MUFC coaches or staff to inform them about matters affecting the player and to advise of any changes of contact, injury or other details.
- 4. I agree to indemnify MUFC and any MUFC Employee, Contractor, Officer, Coach, Team Manager, Support Staff or any other program personnel against all liability arising out of or in connection with any loss, damage or injury suffered by the player when engaged in the Program, whether caused while he/she is playing, training for, taking part in or travelling to or from any football game, competition or otherwise.
- 5. I acknowledge that MUFC coaching staff and officials have the right to exercise reasonable discipline over a player in the best interests of the individual and/or team. Such discipline may include, but is not limited to, denying the player an opportunity to undertake the activities or any part thereof, or requiring that the player no longer participate in, or be required to depart from, any activity.
- 6. I acknowledge that both Parents and Players are subject to the terms set out in the <u>Football Federation Australia Statutes, Regulations and Policies</u>, and in addition the <u>FV NPL Rules, Regulations and Policies</u> as well as FV <u>basic policies</u> which are available on the respective Federation's websites, as these apply and may be varied from time to time.
- 7. I consent to the collection, use and disclosure of personal information by MUFC, in its conduct of the Program, in accordance with the law and understand that this personal information may be collected, used and disclosed by MUFC for purposes including player health and welfare, registration, organisation and conduct of the Program, evaluation and reporting requirements and related purposes. I understand I may access this personal information as permitted by law.
- 8. I consent to photographs and videos to be regularly taken and published by MUFC staff, members and media partners during games and training sessions and then posted publicly on our social media sites, website and in the local media. I hereby permit and authorise MUFC and its media partners to take photographs and/or video footage of my child. This may be used in the creation and production of promotional material for display on social media platforms, website and in the local news. I acknowledge that the copyright of these photographs and video material and their reproduction in any form belong to and is owned by MUFC.
- 9. I acknowledge failure to complete payment for registration as required may see the player excluded from current and future MUFC programs and competitions.
- 10. I acknowledge that MUFC players, parents and supporters will be held personally liable for any fines they incur due to misconduct.
