## **PLAYER/PARENT/MEMBER TERMS AND CONDITIONS**

I, being the player/parent/guardian/member identified in this agreement, understand and agree to the following:

- 1) These Terms and Conditions apply to all players and non-players (volunteers, coaches, team managers) and their parents/guardians and if the registered participant is under 18 years of age.
- 2) By registering with Football Australia using the Football Australia Registration System (**PlayFootball**) you (the Member) (and, if the Member is under 18 years of age, the Member's parent or legal guardian) agree to abide by the **Football Australia PlayFootball Registration Terms and Conditions** and the Football Victoria **PlayFootball Registration Terms and Conditions** as well as these **Player Terms and Conditions** in relation to your participation with Murray United Football Club (the Club).
- 3) I acknowledge that subject to the terms set out in Football Australia Statutes, Regulations and Policies, and in addition the Football Victoria Rules, Regulations and Policies as well as the Club Rules, Regulations and Policies including as may be varied from time to time.
- 4) Allocation of players into teams will be at the discretion of the Club.
- 5) Players and non-playing role participants acknowledge that football is a contact sport and accordingly players/parents and children release and indemnify the Club in respect of any claim whatsoever arising out of any injury, loss or damage suffered as a result of any player participating in any authorised or unauthorised Club football training or game. Although players are covered by *Football Victoria Personal Accident Insurance Cover* (Cover) whilst playing or training, players/parents acknowledge that the Club will not be liable for any cost not covered by the Cover. The Club strongly recommends that you/your children be covered by your own Ambulance cover, Private health insurance or have a Health care/Pension card that provides access to Ambulance cover. I understand Football Victoria insurance is not intended to be a substitute for Ambulance cover or private health insurance and that I will need to evaluate my own insurance requirements.
- 6) I agree to indemnify the Club and any Employee, Contractor, Officer, Coach, Team Manager, Support Staff or any other Club personnel against all liability arising out of or in connection with any loss, damage or injury suffered by the Member when engaged in Club operations, whether caused while he/she is playing, training for, taking part in or travelling to or from any football game, competition or otherwise.
- 7) In case of an emergency, I authorise the person/s responsible to consent where it is impossible to communicate with me, to my child receiving such medical treatment as may be deemed necessary by First Aid requirements and or a qualified medical practitioner.

- 8) I agree to promptly communicate to the Club, coaches or staff to inform them about matters affecting the player or member and to advise of any changes in health, injury or otherwise.
- 9) We are a Club with a heavy reliance on player, parent and member support. Over the course of the season, we will make reasonable requests to all players, parents and members to volunteer time with activities such as the set-up of grounds, 'running the line', team-management and assisting with Club fundraisers.
- 10) I acknowledge that the Club coaching staff and officials have the right to exercise reasonable discipline over a player or member in the best interests of the Club, individual and/or team. Such discipline may include, but is not limited to, denying the player or member an opportunity to undertake the activities or any part thereof, or requiring that the player or member no longer participate in, or be removed from the Club.
- 11) I consent to the collection, use and disclosure of personal information by the Club, in its conduct of Club operations, in accordance with the law and understand that personal information may be collected, used and disclosed by the Club for purposes including player health and welfare, registration, organisation and conduct of the program, evaluation and reporting requirements and related purposes. I understand I may access this personal information as permitted by law. Further to the Privacy Statements in both the *Football Australia and Football Victoria PlayFootball Terms and Conditions* documents, by registering you accept that your contact details may be released to the Coach, Program Manager, Team Manager and any other necessary party internal to the Club for the purposes of communication and the administration of football.
- 12) I consent to photographs and videos to be regularly taken and published by Club staff, members and media partners during training, games and Club operations and then posted publicly on social media sites, website and in the local media. I hereby permit and authorise the Club and its media partners to take photographs and/or video footage of me/my child. This may be used in the creation and production of promotional material for display on social media platforms, website and in the local news. I acknowledge that the copyright of these photographs and video material and their reproduction in any form belong to and is owned by the Club.
- 13) It is a legal requirement for the Club to obtain the details of any individual over the age of 18 that is supporting the Club in a non-playing capacity (e.g. Coach, Team Manager, Administrator). Please see the *Working with Children Check Policy* for further details.
- 14) I acknowledge failure to complete full payment for registration as required by the Club may see the player or member excluded from Club programs and competitions.
- 15) I acknowledge and agree to the Clubs current Refund Policy as listed on the website.
- 16) I acknowledge that the Club's players, parents and members will be held personally liable for any fines they incur due to misconduct.

The above Terms and Conditions will be on the PlayFootball registration system. You will be required to confirm you have read and accepted them prior to your online registration being approved.
